We show the top 15 Latino-owned types of businesses, the metropolitan areas where Latino business owners are clustered, and the broad industries into which the detailed types of businesses fit.


Latino and Hispanic are used interchangeably. "Immigrant" refers to all people born in another country living in the United States, irrespective of legal status.
